**Summary**

Judith Nora Hardt is a political theorist specializing in International Relations, Security Studies, Peace and Conflict Studies, Anthropocene Studies and Climate Politics, with a focus on the governance and security implications of climate change. She completed her PhD in International Relations at the University of the Basque Country (Spain) in 2014 (summa cum laude), funded by a competitive four-year grant awarded by the Basque Government. She is currently a postdoctoral researcher at the Franco-German research center Centre Marc Bloch. Since 2017, she has been a member of the research group “Climate Change and Security” at the University of Hamburg and is an associated researcher at the Institute for Peace Research and Security Policy (IFSH) in Hamburg.

With over 11,762 reads, 301 citations and 383.0 Research Interest Score she has published 3 books, 15 book chapters, and 14 journal articles (9 peer-reviewed and 5 reviewed), as well as 2 special issues and reports and 3 policy briefs. She has secured 4 third-party funded research projects and established 4 international research networks. In addition, she contributes to public and academic debate through podcasts, video formats, and numerous presentations at international conferences, highlighting her strong international profile and leadership in climate and security research.
